

AN ORDINANCE TO REPEAL TITLE XV, CHAPTER 154, ARTICLE 4 AND REPLACE WITH THE AMENDED CHAPTER 154, ARTICLE 4 OF THE CITY OF CHEBOYGAN ZONING ORDINANCE TO ALLOW MEDICAL MARIJUANA PROVISIONING CENTERS IN THE B-4 GENERAL COMMERCIAL DISTRICT.

THE CITY OF CHEBOYGAN ORDAINS:

**TITLE XV, CHAPTER 154, ARTICLE 4
B-2 CENTRAL BUSINESS DISTRICTS**

Section 4.13 and 4.20 – Permitted Use

Medical marijuana provisioning centers as authorized by City Ordinance, not to exceed a total of Two (2).

**TITLE XV, CHAPTER 154, ARTICLE 4
B-3 GENERAL BUSINESS DISTRICTS**

Section 4.14 and 4.20 – Permitted Use

Medical marijuana provisioning centers as authorized by City Ordinance.

**TITLE XV, CHAPTER 154, ARTICLE 4
B-4 GENERAL COMMERCIAL DISTRICTS**

Section 4.15 and 4.20 – Permitted Use

Medical marijuana provisioning centers as authorized by City Ordinance.

**TITLE XV, CHAPTER 154, ARTICLE 4
I-1 LIGHT INDUSTRIAL DISTRICTS**

Section 4.18 and 4.20 – Permitted Uses

A medical marijuana grower as authorized by City Ordinance.

A medical marijuana processor as authorized by City Ordinance.

A medical marijuana secure transporter as authorized by City Ordinance.

A medical marijuana safety compliance facility as authorized by the City Ordinance.

**TITLE XV, CHAPTER 154, ARTICLE 4
I-2 HEAVY INDUSTRIAL DISTRICTS**

Section 4.19 and 4.20 – Permitted Uses

A medical marijuana grower as authorized by City Ordinance.

A medical marijuana processor as authorized by City Ordinance.

A medical marijuana secure transporter as authorized by City Ordinance.

A medical marijuana safety compliance facility as authorized by the City Ordinance.

This Ordinance is effective twenty (20) days from the date of passage by the City Council.


