

**ORDINANCE ADDRESSING FLOODPLAIN MANAGEMENT PROVISIONS
OF THE STATE CONSTRUCTION CODE**

AN ORDINANCE TO AMEND CHAPTER 157 OF TITLE "CITY OF CHEBOYGAN
FLOODPLAIN MANAGEMENT ORDINANCE" OF THE CODE OF THE CITY OF
CHEBOYGAN.

An ordinance amendment to designate an enforcing agency to discharge the responsibility of the City of Cheboygan (CITY) located in Cheboygan County, and to designate regulated flood hazard areas under the provisions of the State Construction Code Act, Act No. 230 of the Public Acts of 1972, as amended.

The City of Cheboygan, Cheboygan County, Michigan ordains:

Section 1. AGENCY DESIGNATED. Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, the Building Safety Department of Cheboygan County is hereby designated as the enforcing agency to discharge the responsibility of City of Cheboygan, Cheboygan County, Michigan under Act 230, of the Public Acts of 1972, as amended, State of Michigan. Cheboygan County assumes responsibility for the administration and enforcement of said Act throughout the corporate limits of the City of Cheboygan.

Section 2. CODE APPENDIX ENFORCED. Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, Appendix G of the Michigan Building Code shall be enforced by the enforcing agency within the jurisdiction of the CITY.

Section 3. DESIGNATION OF REGULATED FLOOD PRONE HAZARD AREAS.
The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) Entitled "Flood Insurance Study Federal Emergency Management Agency, Cheboygan County (All Jurisdictions) and dated 7/19/2022 and the Flood Insurance Rate Map(s) (FIRMS) panel 26031C0230C, effective 8/16/2012 and panels 26031CIND0B, 26031C0111D, 26031C0112D, 26031C0113D, 26031C0114D, 26031C0120D effective 7/19/2022 are adopted by reference for

the purposes of administration of the Michigan Construction Code, and declared to be a part of Section 1612.3 of the Michigan Building Code, and to provide the content of the “Flood Hazards” section of Table R301.2(1) of the Michigan Residential Code.

Section 4. REPEALS. All Ordinances inconsistent with the provisions of this Ordinance are hereby repealed.

Section 5. PUBLICATION. This Ordinance shall be effective after legal publication and in accordance with the provisions of the Act governing same.

AN ORDINANCE TO DESIGNATE AN ENFORCING AGENCY TO DISCHARGE THE RESPONSIBILITY OF THE CITY OF CHEBOYGAN, CHEBOYGAN COUNTY, MICHIGAN AND TO DESIGNATE REGULATED FLOOD HAZARD AREAS UNDER THE PROVISIONS OF THE STATE CONSTRUCTION CODE ACT, ACT NO. 230 OF THE PUBLIC ACTS OF 1972 AS AMENDED.

THE CITY OF CHEBOYGAN, CHEBOYGAN COUNTY, MICHIGAN ORDAINS:

A. AGENCY DESIGNATED.

Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, the Building Official of Cheboygan County is hereby designated as the enforcing agency to discharge the responsibility of the City of Cheboygan, Cheboygan County, Michigan under Act 230, of the Public Acts of 1972, as amended. Cheboygan County has assumed responsibility for the administration and enforcement of said Act throughout the corporate limits of the City of Cheboygan.

B. CODE APPENDIX ENFORCED.

Pursuant To The Provisions Of The State Construction Code, In Accordance With Section 8b(6) Of Act 230, Of The Public Acts of 1972, As Amended, Appendix G Of The Michigan Building Code Shall Be Enforced By The Cheboygan County Building Official Throughout The Corporate Limits of the City of Cheboygan.

C. DESIGNATION OF REGULATED FLOOD PRONE HAZARD AREAS.

The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) Entitled "Cheboygan County, Michigan (All Jurisdictions" and dated 8/16/12 and the Flood Insurance Rate Map(s) (FIRMS) panel number(s) of 26031C, 0115C, 0120C, and 0230C dated 8/16/12 are adopted by reference for the purposes of administration of the Michigan Construction Code, and declared to be a part of Section 1612.3 of the Michigan Building Code, and to provide the content of the "Flood Hazards" section of Table R301.2(1) of the Michigan Residential Code.

D. REPEALS.

All ordinances inconsistent with the provisions of this ordinance are hereby repealed.

E. EFFECTIVE DATE.

This ordinance shall be effective following its publication and in a newspaper of general circulation with the City, Public hearing thereon and adoption by a quorum of City Council.
