AGREEMENT

Agreement made this day of, 20, by and between THE CITY OF CHEBOYGAN, a Michigan Municipal Corporation, hereinafter referred to as
"City", and
of, Cheboygan,
Michigan, hereinafter referred to as "Resident".
WITNESSETH:
WHEREAS, Resident is desirous of having a sidewalk at (his/her/their) (residence/business) constructed and/or replaced and is without sufficient funds to pay for such construction and/or replacement but is desirous of having the work done in the near future; and
WHEREAS, the City is willing to provide the necessary labor and/or materials or to have the same provided by a contractor of its choice and the City is further willing to pay for such labor and materials subject to repayment to the City by the Resident in the method described below.
NOW THEREFORE, in consideration of the mutual covenants contained herein, the parties hereto agree as follows:
The City shall provide the necessary labor and/or materials (or to have the same provided by a contractor of its choice) for the construction or replacement of a sidewalk abutting the premises described as

 The Resident hereby agrees to pay the City for all expenses for the construction or replacement of said sidewalk or for such portion thereof as the City Council of the City of Cheboygan shall determine.
3. That the terms and conditions of such payments mentioned in paragraph 2 shall be set by the City. Amount Financed Term in Years
4. That all such expenses are made a lien upon the lot or premises adjacent to and abutting upon such sidewalk and the City Clerk for the City of Cheboygan shall, on the Tuesday following the second Monday in March of each year, certify to the City Council, at their regular Council meeting, the amounts which are due and owing to the City of Cheboygan for such expenses.

- 5. That the City Council, no later than the Tuesday following the second Monday in April, shall at these regular Council meetings, direct the City Assessor to spread the amounts against the premises described in paragraph 4.
 - 6. That such expenses shall be collected in the same manner as general City taxes.
- 7. That the Resident hereby agrees that all rights granted by the statutes and other law of the State of Michigan and the Code of Ordinances of the City of Cheboygan concerning special assessments and the creation of special assessment liens are hereby waived.
