#### NOTICE OF PROPERTY INSPECTION

The City of Cheboygan is in the process of updating all property record cards over the course of the next few years. Someone may be stopping at your property to update the property record card this year or in the near future. The inspection includes a complete re-measuring of the land improvements along with listing the building improvements. Also, digital images will be taken for the record. Some questions such as how many bedrooms, bathrooms and interior finish may be asked if you are home. Access to your home is not asked for or required for this project.

#### CITY BLIGHT COMMITTEE

The City Council formed a Blight Committee. Members are City Manager Thomas Eustice; Police Chief Kurt R. Jones; Councilman Vaughn Temple; Councilman Nate King; and Citizen James Conboy, Jr. The Department of Public Safety has been proactive in addressing the blight issues within the City. See Blight Ordinance below as to what a property owner can be cited for. We ask your cooperation in taking care of your property, which includes grass/weed cutting. The City Council is committed to stricter blight issue enforcements beyond grass cutting and vehicles.

#### **ORDINANCES**

**BLIGHT:** Chapter 95.06 states that "It shall be unlawful for any person to keep or maintain a garish exterior upon any vacant structure, building, dwelling, garage, or outbuilding, factory shop, store, or warehouse..." "All exterior property areas shall be properly maintained in a clean and sanitary condition, free from debris, brush, severed tree limbs, rubbish or garbage, physical hazards, rodent harborage and infestation; storage or placement of junk refuse or other objects, including, but not limited to, campers, trailers, lawnmowers, snowmobiles, tractors, motorcycles, boats, and others items not having been used recently for their original intended purpose in the right-of-way, yard, front porch or outside area exposed to the view of neighbors or the general public is prohibited, unless a temporary permit is issued by the City Manager."

<u>DUMPSTER PERMITS:</u> Chapter 95.02, paragraph 12, of the City Ordinances prohibits dumpsters at single family residences unless a **TEMPORARY PERMIT** is issued by the Director of Public Safety or City Manager. Permits are free and may be picked up at the Cheboygan Department of Public Safety M-Th 9:30 am-2:30 pm and Friday 9:30 am-1:30 pm. If you have any questions regarding Dumpster Permits, please contact the Department of Public Safety at (231) 627-4321.

#### NOTICE:

The City of Cheboygan does not discriminate on the basis of disability in the admission or access to, or treatment or employment in, its programs or activities. ## WATER/SEWER EMERGENCIES

If you experience a water or sewer emergency during normal business hours, please call 627-2582. Should you experience a water or sewer emergency after normal business hours or on a weekend or holiday, the City staff is committed to providing emergency response. To provide that response, you may dial 290-2900 to reach an employee of the Department of Public Works. Please remember that this system is for emergency situations, not for general information that can be obtained during normal working hours.

### WATER SHUT-OFF INFORMATION

Customers who have their water shut off and have to have Department of Public Works personnel restore service will be charged a \$40.00 Turn On Fee. This will include seasonal customers, non-payment customers and anyone discontinuing service for a period of 30 days or more.

# PERMITS REQUIRED FOR WORK IN STREET RIGHTS-OF-WAY

Anyone planning to perform any type of work within a City street right-of-way must secure a Permit from the City of Cheboygan's Department of Public Works. Work requiring a Permit within a street right-of-way includes patch work, culvert installation, curb, sidewalk or driveway repair, tree or shrub planting or any other type of work within the street right-of-way. Please contact Jason L. Karmol, Director, Department of Public Works, at 627-2592, if you plan work in the street right-of-way or have questions concerning street rights-of-way.



#### **Grass & Weed Notice**

Property owners, residential & business, are required to cut the right-of-way (berm area), as well as their personal property. City crews are mowing private properties that are in violation of the City Ordinance. The minimum charge is \$175/per hour and will be placed on property taxes levied in July. Also, the property owner can be cited for the violation.

Brush, tree limbs, grass clippings, etc. can be taken to the drop-off area at the Department of Public Works garage for disposal between 7:00 am & 3:00 p.m. Monday-Friday at no charge.



#### **Public Notice**

Any citizen having experienced an overflow or backup of a sewage disposal or storm water system must file a written claim with the City of Cheboygan within 45 days after the discovery or in the exercise of reasonable diligence should have been discovered. Failure to provide the required notice to the City Manager, 403 N. Huron St., PO Box 39, Cheboygan, MI 49721 will prevent recovery of damages.



#### City Marina & Public Restroom Information

The Cheboygan City Marina consists of over 800' of broadside dockage at two dock sites on the west side of the Cheboygan River just south of the State Street Drawbridge. Interested boaters may make reservations for overmight docking through the D.N.R. web site at midnmeservations.com or by simply tying up along the Marina wall and a dock attendant will stop by morning, noon.

The Cheboygan City Marina provides restroom facilities along with water and power hook-ups for registered boaters. Fuel and pump out facilities are available at the County Marina at the mouth of the Cheboygan River and the Straits of Mackinac. 

## O RDINANCE REMINDERS FROM THE DEPARTMENT OF PUBLIC SAFETY



**YARD SALE SIGNS:** Are not to be placed in the public right-of- way or placed on any utility pole. They should be placed behind the curb, sidewalk or ditch line, with permission of the property owner.

<u>UNLICENSED/INOPERABLE MOTOR VEHICLES:</u> Chapter 94.02 of the City Ordinance states that "Any motor vehicle parked on your property in the City must be in operating condition and be licensed and insured for use in accordance with the requirements of the Michigan Vehicle Code" Vehicles not being used for original intended purposes **are in violation**.

**BOAT & TRAILER STORAGE:** Chapter 154.136 of the City Ordinance states "All trailer coaches or boats owned by residents of the city and stored on their individual lots shall not be stored within any required front or side yard." **MUST BE IN REAR YARD** 

**GRASS & NOXIOUS WEED:** Chapter 95.04 of the City Ordinance "No person occupying any premises, and no person owning any unoccupied premises shall permit or maintain on any such premises any growth of noxious weeds; nor any growth of grass or other rank vegetation to a greater height than **five inches** on the average; nor any accumulation of dead weeds, grass or brush. Lawns shall be cut (grass can be no higher than five inches) and maintained 50 feet from the property line in developed areas, whether or not the same is occupied, and of a primary business structure." Cutting by the City is **\$175.00 per hour** and placed on the tax roll.

**TRASH PICKUP:** Chapter 95.02 prohibits "The placing of garbage containers, dumpsters or trash receptacles in a public right-of-way except on collection day." Placing furniture or other items out for trash pickup is not allowed except on trash day and must be prearranged for pickup with your trash company. Trash is to be in approved containers (metal or plastic) not just trash bags that can be torn apart by animals and containers must be removed from the right-of-way after trash is picked up at the end of the day.

NOISE: Chapter 95.03 prohibits "The playing of any radio, television set, phonograph, or any musical instrument in such a manner or with such volume, particularly during the hours between 11:00 p.m. and 7:00 a.m., or at any time or place so as to annoy or disturb the quiet, comfort, or repose of persons in any office or in any dwelling, hotel, or other type of residence, or of any persons in the vicinity; Yelling, shouting, hooting, whistling, or singing or the making of any other loud noise on the public streets between the hours of 11:00 p.m. and 7:00 a.m., or the making of any such noise at any time so as to annoy or disturb the quiet, comfort, or repose of persons."

**FIREWORKS:** Chapter 130.03 prohibits "The fire, discharge, display or possess any fireworks except of the type permitted by state law." No fireworks are to be discharged between the hours of 1:00 a.m. and 8:00 a.m.; fireworks are only permitted to be discharged on the day before a national holiday, the day of the national holiday and the day after a national holiday. A person must be at least 18 years of age to purchase, acquire or obtain any legal fireworks. Michigan Fireworks Safety Act 256 of 2011 can be found on the complied laws website at Michigan.gov and the City of Cheboygan website under City Ordinances Chapter 95.03, Noise Nuisance at <a href="https://www.cheboygan.org">www.cheboygan.org</a>.
