ARTIST PERFORMANCE AGREEMENT

FOR DREW HALE MUSIC, LLC

THIS AGREEMENT dated as of April 1, 2018, is by and between Drew Hale Music, LLC (hereinafter "Artist") and the City of Cheboygan Downtown Development Authority (hereinafter referred to as "Promoter").

WHEREAS, Promoter desires to promote, manage, and operate a musical entertainment event ("Concert");

WHEREAS, Promoter desires to hire Artist, as independent contractor, to provide the entertainment generally described below (the "Performance") at the Concert; and

WHEREAS, Artist desires to provide such Performance at the Concert;

NOW, THEREFORE, the parties agree as follows:

- 1. Date and Time of Performance.
 - a. The date(s) of the performance shall be:
 - July 28, 2018 and the time(s) of the Performance shall be 8:00pm 11:00pm.
- 2. Performance.
 - a. The entertainment to be provided by the Artist is generally described as:
 - i. A musical performance consisting of a live four-piece band for two (2), seventy-five (75) minute sets with one (1), thirty (30) minute break.
- 3. Agreement to Perform.
 - Artist agrees to provide the Performance in accordance with the terms of this Agreement and any addendums or riders hereto.
- 4. Price of Performance.
 - a. Promoter agrees to pay Artist:
 - A flat fee of \$2000 (hereinafter being referred to as the "Guaranteed Compensation"). It is understood such Guaranteed Compensation shall be payable in all events, whether or not Promoter cancels the Performance.
 - ii. The Guaranteed Compensation (without any tax withholdings therefrom) shall be remitted to Artist net of all conversion and transmission costs of funds and be paid to Artist (i) \$500 (refundable only upon meeting criteria in Section "7. Excuse of Obligations") on execution hereof; (ii) \$1500 upon arrival for performance on July 28, 2018; in U.S. currency, by wire transfer of good current funds, cash or certified check or bank draft.

Merchandise.

- a. Artist supports their livelihood by performing. Merchandise sales help subsidize the costs for traveling and promotion of the band.
- b. Merchandise will be sold at this Performance at the discretion of the Artist.
- c. Pricing is decided by the Artist.
- d. If Promoter has a Merchandise Sales Policy, it will need to be agreed upon, in writing by the Artist or his representation as part of the contract agreement.
- 6. Recording, Reproduction, or Transmission of Performance.
 - a. Promoter will use its best efforts to prevent the recording, reproduction, or transmission of the Performance without the written permission of Artist or Artist's representative.
- 7. Excuse of Obligations.
 - a. Promoter and Artist shall be excused from their respective obligations hereunder in the event of proven sickness, accident, riot, strike, epidemic, act of God, or any other legitimate condition or occurrence beyond their respective control (decided upon a mutual agreement of the Artist and the Promoter before cancellation).
 - b. Cancellation of Performance by Promoter that does not meet the above stipulations or happens less than six (6) weeks prior to Performance, requires 100% of Guaranteed Compensation to the Artist by the Promoter.
 - c. If everyday weather (rain, cold, etc.) forces Promoter to cancel Performance, 50% of Guaranteed Compensation, or a change in date is required. If Promoter cancels after Artist has begun traveling, Travel expenses of \$75/hour will be additionally required. If Artist has not begun traveling, 50% of Guaranteed Compensation or a change in date is only required.

8. Taxes.

- a. Promoter agrees to prepare and file all tax information required of a person who hires an independent contractor and Artist agrees that it has sole responsibility for the payment of any federal or state taxes arising from the monies paid by Promoter to Artist for the Performance.
- 9. Indemnity for Copyright Infringement.
 - a. Artist represents and warrants that it is knowledgeable about the copyright laws of the United States as applicable to the Performance and that Artist shall not perform any copyrighted materials of others during the Performance without full compliance with such applicable copyright laws. In the event that Artist breaches this representation, warranty, and covenant, Artist hereby agrees to indemnify and hold harmless Promoter and its employees, guests, and agents from and against all liability, loss, damages, claims, and expenses (including attorney's fees) arising out of such breach.
- 10. Independent Contractor.
 - a. Artist acknowledges that it shall perform its obligations hereunder as an independent contractor and not as an employee of Promoter. Artist further acknowledges that it is not on Promoter's payroll and social security or tax

withholding rolls. Artist shall have sole control and direction in the conduct of the Performance.

11. Promotion.

- a. Promoter shall be entitled to advertise and promote the appearance of Artist at the Concert and the Performance. Artist acknowledges that Promoter will rely on the terms hereof in all such promotions and advertising and in the brochures to be printed setting forth the names, dates and times of all performances to be held at Concert. Promotion is encouraged on Facebook (including Facebook Live), Twitter, and Instagram (including videos). Artist hereby acknowledges and agrees that Promoter may use their names, photographs, likeness, facsimile signature and any other promotional materials in all of such promotions, advertising or other activities used to increase attendance at the Concert.

Promoter shall provide parking space for vehicles in a location of close proximity to and with direct access to the backstage/performance area where Performance will take place on the date of Performance. This parking space will be reserved for Artist for a period of four (4) hours prior to the Performance and ending three (3) hours following the Performance.
- 13. Security.
 - a. Promoter shall provide security for the backstage and stage areas before, during and after the Performance. Promoter shall provide security personnel to protect Artist and its property as deemed appropriate by Promoter in its discretion.

Passes.

 a. Promoter shall provide identification passes to Artist and Artist's assistants for the backstage and stage where Performance is to be held.

15. Stage.

- a. At its sole expense, Promoter shall furnish the stage with
 - i. Appropriate lighting for a period of three (3) hours prior to the Performance and ending three (3) hours following the Performance.
